General

The school building is planned for triple storey as per the maps in a shape of eul-de-sse. The building is housing classroom & toilet. Each floor is 3.60 mt. high from floor to floor. The plinth is 90 cm. high form present ground level. This is a protection against flooding of the area.

The building was inspected by me on 28/05/2015. The construction was thoroughly examined from structural safety points. Exposed structural member were measured for section. Steel is considered as per the drawing made available. The reinforcement in foundation was considered as provided in the drawing. Column reinforcement were inspected and measured at first floor, which were exposed. Slabs were measured and found to be 13-15 cm. in thickness. No differential settlement of the building observed and the building is stable till the day of inspection.

(a) Language Subjects: English Core & Hindi Core.

(b) Elective Subjects: Accountancy, Biology, Business Studies, Chemistry, Computer Science, IP, Economics, Geography, History, Home Science, Mathematics, Painting, Philosophy, Physical Education, Physics, Political Science, Psychology, Sociology, Music Hindustani Vocal Instrumental.

The above sanction is subject to fulfillment of following conditions:-

- 1. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
- The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes
 of the Board upto Classes X vide Circular No. 39/20-09-2009 dated 20.09.2009 in the school and will
 follow the CCE scheme at Secondary level as per the guidelines of the Board issued from time
 to time.
- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT Govt. from time to time.

Provisions of Affiliation bye laws for adherence:-

- Fees should normally be charged under the heads prescribed by the Department of Education of the State/U.T. for schools of different categories. No capitation fee or voluntary donations for gaining admission in the school or for any other purpose should be charged / collected in the name of the school and the school should not subject the child or his or her parents or guardians to any screening procedure i.a.w. rule no. 11.1, 2 & 3.
- The school should not use the activities for commercialization:-2
- As per rule no. 19.1 (ii) It shall ensure that the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
- As per rule no. 19.1 (ii)a Any franchisee school making payment on account of use of name, motto and logo of franchiser institution or any other non-academic activities would be termed as commercialization of institution and to provide an affidavit that the school/society has not entered into any such contract to use Name, logo, motto for consideration of fee.
- Teachers are to be made educated regarding corporal punishment& should avoid any type of such involvement i.a.w. rule no. 44.1 (d & e).
- School will not prepare any student/ start class for any other Board except CBSE from their CBSE affiliated school building/ premises.
- Admission to the school is to be made restricted under rule 6.1 of Examination bye laws and rule 12 (i, ii & iii) of Affiliation bye laws.
- The school has to constitute a committee for protection of woman from sexual harassment at the work place and to abide by the guidelines and norms prescribed by the Hon'ble Supreme Court of India in W.P. - 8. The school will also abide itself by the conditions of affiliation already prescribed by the State Government concerned.
- 9. As per Affiliation Bye-laws the optimum strength of a section should not exceed more than 40 students.
- 10. School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured.
- 11. The section teacher ratio of 1:1.5 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
- 12. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
- 13. The school will strictly adhere with all rules regarding safety of students including Fire fighting and Transportation, etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.
- 14. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws.
- 15. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee. Of these 2-3 may be Principal of KV/JNV.
- 16. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared in the name of school, as per rules. A copy each of the Statements of Accounts should be sent to the Board every year.
- 17. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
- 18. The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.

The school will apply for further Extension of Provisional Affiliation 'on online' through<u>www.cbseaff.nic.in</u> with the prescribed fee of `. **25,000**/- and other essential documents before 30thJune of the preceding year before the expiry of the date of provisional affiliation otherwise penalty
